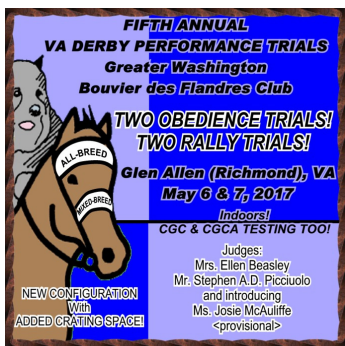

## IMPORTANT

TRANSFERS (MOVE UP) OF DOGS IN OBEDIENCE/RALLY CLASSES (Ch. 1 Section 16 of Obedience Regulations) The request for transfer move up must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial each day. These may be approved, provided the next level class and judge are available and the class has not reached its limit.

## NOTICES TO EXHIBITORS

ENTRY FEE REFUNDS: Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, or weather emergencies or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.

REFUND FOR BITCHES IN SEASON: The club will retain a \$15.00 processing fee. Refund of entry fees for bitches entered in Obedience or Rally that come in season after closing date of this trial may be obtained by sending a veterinarian's certificate to the show secretary, postmarked before the opening day of the show - or given to the show secretary before the start of the trial.

In accordance with AKC rules, only dogs entered in these Trials will be permitted to enter the trial areas. Limited indoor crating space available at this Trial. Additional crating outdoors will be available.

No dog may be permanently removed from the show before it is judged except by consent of the Trial Secretary upon a Veterinarian's recommendation of removal.
